Transformation Remover is a SCENE Plug-In which easily deletes the transformation data from clusters and other objects.

It can be started via

- menu: "scantaxi/Transformation Remover"
- toolbar: 🛅 Transformation Remover




Figure 1: Access Transformation Remover




Figure 2: Result of Transformation Remover

As part of the installation procedure for the new version, the old version must be removed (1, 2). Following this, Transformation Remover can be installed via App Manager (3), drag and drop or by double clicking on the app file in the Explorer.

### 5 Using Transformation Remover

You can delete the transformation of various objects (fig. 4).

- Button (1) remove the transformation in every cluster
- Button (2) remove the transformation in every scan (this has more options)
  - Button (3) restores the Inclinometer data (this has more options, too)
    - \* Button (4) copies the compass to the transformation
    - \* Button (5) copies the altimeter to the transformation

#### 7 End User License Agreement
